CHILD OF THE SPOUSE OF ITALIAN/EU**

<b>1.</b>	<b>ENTRY VISA APPLICATION FORM</b>
	COMPLETELY filled in "Schengen Visa" <a href="#">APPLICATION FORM</a> (Please DO NOT leave blanks in the form. Indicate "NA" if answer is not applicable. <i>For minors, application must be signed by BOTH parents</i> )
<b>2.</b>	<b>PHOTO</b>
	One (1) recent passport-sized or 2x2 colored ICAO standard photo with white background (ears should be exposed and with collared shirt/blouse)
<b>3.</b>	<b>TRAVEL DOCUMENT</b>
	Current valid passports (expiry date is three months longer than that of the visa requested but please consider the 6 months validity as required by the Philippines Bureau of Immigration)
	Photocopy of Biographical page and last page of the valid passport, previous visa and immigration stamps in all countries
<b>4.</b>	<b>PROOF OF TRAVEL</b>
	One-way Flight Booking
<b>5.</b>	<b>INVITATION</b>
	Invitation Letter (format of this letter may be downloaded <a href="#">HERE</a> ). Properly filled up and signed by Italian/EU parent/s
<b>6.</b>	<b>DOCUMENTATION PROVING THE STATUS OF FAMILY MEMBER OF THE FOREIGN CITIZEN RESIDENT IN ITALY</b>
	Clear photocopy of the Italian/EU passport of parent/s
<b>7.</b>	<b>PROOF OF RELATIONSHIP</b>
	Original and photocopy of the applicant's Birth Certificate issued by NSO and authenticated by DFA within six (6) months and formally translated in Italian language
	Photocopy of Marriage Certificate registered in the Italian Municipality of Residence (Estratto di Matrimonio rilasciato dal Comune di residenza) or the transmission of registration of the marriage certificate to the Italian Municipality performed by the Consular Section. For spouse of other EU citizens, Marriage Certificate registered in their pertinent EU country.
	For minors, Notarized Affidavit of Consent of the other Parent with attached valid document of identity. If one parent passed away, NSO death certificate legalized by DFA
	In case applicant is descendant of the Italian/EU citizen (or of EU citizen spouse) and is older than 21 years of age, proof of dependency must be provided
<b>8.</b>	<b>VISA FEE</b>
	Service Fee in Cash ( Personal Appearance at VIA Centre)
